New Drugs

Description:

This activity will update participants on new drugs that have recently entered the U.S. market.

At the conclusion of this activity, participants should be better able to:

- Identify new agents that have recently entered the U.S. market and are significant pharmacotherapeutic advances.
- Describe the mechanism(s) of action of these agents, typical dose(s) used, common adverse reactions and/or contraindications associated with their use.
- Discuss appropriate use of these new agents, comparing them with older agents used for the same indications.
- List special patient instructions and/or monitoring parameters required with the use of these agents.
- Pharmacy Technicians List new agents and their therapeutic indications.
- Pharmacy Technicians Educate patients as directed by the pharmacists on the appropriate use of these agents.

Speaker

Scott Perkins, PharmD

Scott Perkins is a Clinical Assistant Professor and Co-director of Drug Information at Campbell University College of Pharmacy & Health Sciences. Born in Charlotte, N.C., he obtained his Doctor of Pharmacy degree from Wingate University School of Pharmacy in 2012 and completed a one-year, drug information residency at Wingate's Drug Information Center thereafter. Scott began working at Campbell University's College of Pharmacy and Health Sciences in 2014, where he is the course director for Drug Information and Literature Evaluation as well as a preceptor for fourth-year student pharmacists. Scott's research has focused on the use of technology in both health care and health care education, which addresses topics such as the use of electronic health records in the classroom, the evaluation of a mobile app to request drug information and the utilization of fitness devices for patients with type 2 diabetes.

Pharmacy Law

Description:

A good understanding of pharmacy law is essential for every practicing pharmacist and technician. Several important changes to North Carolina and federal law have been implemented and will be reviewed in this knowledgebased continuing education. Thomas R. Thutt, BSPharm, will provide participants with the most up-to-date information on both federal and North Carolina pharmacy laws that impact their practice.

At the conclusion of this activity, participants should be better able to:

- Describe recent changes in rules that affect the practice of pharmacy.
- Explain recent statutory changes, federal and state, that affect the practice of pharmacy.
- Explore various legal "hot topics" affecting the practice of pharmacy, and, in particular, Board of Pharmacy disciplinary emphasis points.
- Pharmacy Technicians Review aspects of pharmacy law that affect dispensing.
- Pharmacy Technicians Evaluate issues that affect pharmacy technicians.

Speaker

Thomas R. Thutt, RPh

Tom Thutt, RPh, will provide participants with the most up-to-date information on both federal and North Carolina state pharmacy laws that impact their practice. A good understanding of pharmacy law is essential for every practicing pharmacist and technician. Any changes that took place during 2016 will be reviewed in this knowledge-based continuing education live and remote live program. Thutt earned a Bachelor of Science degree in pharmacy, now called a PharmD for doctor of pharmacy. Thutt is the founder of the NC Multistate Pharmacy Jurisprudence Examination. This exam combines federaland state-specific questions to test the pharmacy jurisprudence knowledge of prospective pharmacists. Tom Thutt serves as an Adjunct Assistant Professor at the UNC School of Pharmacy. It is here Thutt instructed the Pharmacy Law Class including the yearly ethics lecture on Community Pharmacy for five years. He retired from practicing retail pharmacy in November 2012.
