## Program Overview and Objectives

This vaccination update is a two-hour program to provide the latest guidelines and recommendations regarding pediatric vaccinations. The recommendation for annual vaccination means that health care providers should remain up to date with their knowledge of vaccinations and practices. The knowledge gap this training addresses includes information every vaccine provider should know about infectious disease, the various vaccines, ACIP vaccine recommendations, storage and handling requirements, and administration considerations.

**Upon completion of this knowledge-based program, participants should be able to:**

- Describe the epidemiology and characteristics of vaccine-preventable infectious diseases.
- Summarize recommendations for maternal immunization targeting maternal, fetal and neonatal health such as influenza, Zika, pertussis, RSV, Group B strep and others.
- Describe recent updates of ACIP/CDC recommendations for pediatric vaccinations.
- Summarize recommendations for vaccinations targeting global disease outbreaks such as Dengue, Malaria, Yellow Fever, and Chikungunya.
