

2016 Anticoagulation Certificate Renewal Program

Two-part program includes:

- Home Study, May 23–July 29, 2016
- Case Discussion Options:
Sept. 16 or Sept. 20, 2016



Who Should Attend

The target audience for this renewal program is pharmacists with an active certificate from a UNC-affiliated AHEC in the area of anticoagulation. Pharmacists must have direct access to patients and medical records or be willing to travel to a collaborative practice where these opportunities would be provided.

Program Overview

You must have already completed a UNC-affiliated AHEC Anticoagulation Certificate Program. The renewal program is designed to provide a renewal certificate for pharmacists in the area of anticoagulation management, focusing on management and interpretation of current national guidelines. A total of two patient case work-ups will be required for benchmarking against national guidelines.

Renewal of the certificate will include submitting two cases for review—cases will be due by Aug. 15, 2016. Each pharmacist must complete a two-hour didactic session and post-test, and participate in one three-hour case discussion session, presenting one of the two cases.

Once participants complete the module, they must score 80 percent on a post-test and attend one case discussion session (three-hour live program). If a participant scores less than 80 percent on the post-test, a re-test will be given. The lecture will be uploaded by May 23, 2016, for review. No partial credit will be given if the participant does not complete the entire program.

Goal

This application-based activity is intended to provide pharmacists with disease-state management skills to care for their patients who require anticoagulation.

Evaluation Process

- Submit two patient write-ups for evaluation and benchmarking against national guidelines.
- Participates must present one case work-up at a “Case Discussion Session” and respond to the feedback provided.

A passing test score must be achieved prior to case presentations.

Participants must successfully complete the home study didactic sessions (modules and post-test) prior to the Case Discussion Session.

Payment Policy—Payment is required on or before entrance into any Northwest AHEC activity.
