Pharmacists, Pharmacy Technicians, Physicians, Physicians Assistants, Nurse Practitioners

## <u>Goal</u>

This knowledge-based CPE activity will provide participants with in-depth knowledge of drug information references that will be useful in a variety of practice settings. Internet resources and mobile applications will be discussed. Secondary databases, primarily PubMed, will be discussed and participants will be introduced to advanced searching techniques to optimize a literature search retrieval.

At the completion of this knowledge-based activity, the participant should be able to:

#### Pharmacist Course Objectives:

- Identify drug information Internet resources and select the most appropriate resource for a specific request
- Describe the role of mobile applications for the provision of drug information in a variety of practice settings
- Define secondary databases and list secondary databases useful in the biomedical sciences
- Describe a systematic approach to searching secondary databases
- Explain advanced search strategies in PubMed to perform an effective literature search

• Discuss the process for performing an organized search of the biomedical literature in PubMed when given a specific drug information request.
