# Program Description:

Patients with HIV now have life expectancies equal to the general US population when properly managed with combination antiretroviral therapy. With this life expectancy, there are more and more elderly patients living with HIV each year. Almost 10% of those infected with HIV have chronic kidney disease (CKD), complicating HIV regimen selection and dosing. The management of HIV in CKD is an area that pharmacists can play an important role in to reduce adverse events and further improve patient outcomes. At Cone Health, patients with HIV and CKD can be admitted to any service depending on their admitting diagnosis. Therefore, it is vital for all pharmacists to understand the potential complications and treatment for these patients to provide exceptional pharmaceutical care.
