

Who Should Attend?

Registered nurses, pharmacists, dietitians, clinical psychologists, occupational therapists, optometrists, physical therapists, physicians, physician assistants, exercise physiologists (certified ACSM), podiatrists, and health care professionals with a master's degrees or higher in social work who are interested in learning more about Diabetes and sitting for the certification exam to become Certified Diabetic Educators[®].

Who Qualifies to Take the Exam?

Objectives

Upon completion of this knowledge-based program, participants will be able to:

- Identify knowledge needed to successfully prepare to take the certification exam;
- Assess learning and self-care behaviors of the patient with diabetes;
- Describe successful interviewing techniques to obtain a complete health history and patient needs specific to diabetes;
- Discuss current treatment guidelines for the patient with diabetes;
- Identify strategies for enhancing collaboration, compliance, and counseling;
- Describe complications of non-compliance: chronic and acute for the diabetic patient; medical and surgical treatment options;
- Discuss non-insulin pharmacotherapy options for the treatment of type 2 diabetes;
- Discuss different insulin delivery devices;
- Discuss various insulin based regimens for the treatment of diabetes;
- Review special documentation requirements;
- Discuss implications for program development and management; and
- Review principles of nutrition and ADA guidelines.
