DESCRIPTION

Prescription opioid pain medications are responsible for more deaths in North Carolina than heroin and cocaine combined. And, if current trends continue, unintentional poisoning deaths will surpass motor vehicle deaths as the leading cause of injury death in North Carolina by 2017.

This conference will enable the participant to improve their clinical practice knowledge related to limiting personal risk when prescribing and dispensing opiates. Current national and state guidelines for prescribing opiates, risk mitigation strategies in providing adequate pain management, and referral options for specialized substance abuse treatment will be addressed.
