Program Description:

The National Comprehensive Cancer Network Oral Chemotherapy Task Force estimates that about 25% of cancer treatment is provided to patients by an oral formulation. As oral chemotherapy agents become more common, it is important for providers to be familiar with these agents. Pharmacists and pharmacy technicians should know the common oral chemotherapy medications used by patients to easily help identify the need for extra vigilance. It is also important for pharmacists to understand the adverse effects, safety concerns, and drug interactions with common oral chemotherapy medications to provide adequate pharmaceutical care and monitoring for these patients.

Pharmacist Learning Objectives:

1. Identify common chemotherapy agents and review their mechanisms of action along with their appropriate monitoring parameters.
2. Describe potential adverse reactions and important drug interactions for these common chemotherapeutics.
