## Program Description

As you may be aware, medication-related problems and medication mismanagement are a massive public health problem. As pharmacist, medication therapy management (MTM) services are provided in all care settings in which patient take medications. The goal of all pharmacists providing medication therapy management is to make sure that the medication is right for the patient and his or her health conditions and that the best possible outcomes from treatment are achieved. With that being said, the focus of this seven hour program will provide each participant with updates on law, new pain and opioid use disorder guidelines, update on old drugs, and the importance of MTM.

## Objectives

- Cancel 48 business hours before the program and obtain a refund for 70% of the registration fee.

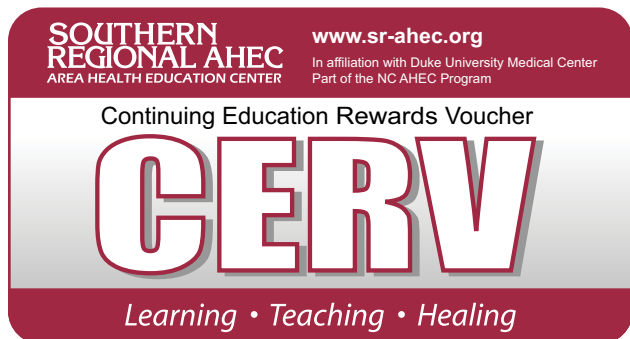
Cancellations less than 48 business hours before the program are non-refundable. Participants who register for a program and do not attend will forfeit the full amount of the program registration fee.
